**गुजरातमध्ये ऑगस्टच्या** अखेरच्या आठवड्यात झालेल्या मुसळधार पावसाने ४९ जणांचा बळी घेतला. पुरामुळे अनेक मुख्य रस्त्यांची वाताहत झाली असन, राष्ट्रीय आपत्ती प्रतिसाद दल (एनडीआरएफ) आणि लष्करासह अनेक यंत्रणांनी ३७ हजारहून अधिक नागरिकांची सुटका केल्याची माहिती प्रशासनातर्फे बुधवारी देण्यात आली.

गुजरातमधील अनेक भागात हवेतील तीव्र कमी दाबामुळे २५ ते ३० ऑगस्ट दरम्यान जोरदार ते अतिमुसळधार पाऊस झाला. गुजरात-राजस्थान सीमेवर निर्माण झालेली ही स्थिती हळूहळू अरबी समुद्रात सरकली (जी नंतर
